# **Justice Department**

Increase in Retirement of \$16256.00

Increased Parks Equipment \$35000.00

Decreased equipment in Water and Sewer for trucks

Moved the Ambulance money to the district \$115,000.00 plus \$50000.00

Increased Airport Project \$27400.00 (\$30900.00)

Increased Tennis Court Project \$87000.00

#### **Possible Budget Increase**

Chris Stone, the Budget Officer, stated that the budget maybe up by as much as 20.8%.

### **Ambulance District**

The Ambulance District will be the last thing on the Budget since they need to meet with the Regional Emergency Medical Advisory Committee in late October.

#### **Cemetery**

The Town of Schroon will be taking on a new Cemetery in South Schroon and it will need to be cleaned and maintained, which will add more to your budget.

#### **Sidewalks**

Sidewalks have not been done in awhile and should be done every year. There is \$10,000.00 put into the Highway Budget for this every year that ends up as fund balance. The Highway Superintendent needs to address this.

#### **Employee Raises**

Employees raises will be done at the last meeting. Chris Stone stated that the Board needs to contact Pubic Sector and go over the hand book. At this time you have a starting salary, a mid point

and a high point. It would be better to have something in between the starting point and the mid point and also between the mid point and the high point. You may want to think about possibly going with a starting point and then something at 5 years, 10 years, 15 years and 20 years. At this point there is nothing in writing.

### **Lake Study(Invasive Species)**

Lake Study will not change much and the lake is getting better.
